PART 2 – AGREEMENT

Important

Terms and Conditions of the Rental Agreement – Please read before signing.

It is understood that the Renting party are responsible for the following:

- Maximum rental period is 7 days (including the days to transport the equipment).
- You are responsible for the safe handling and storage of all equipment.
- Costs are calculated on a daily rate unless otherwise specified.
- Return of the equipment in the same condition as when it was rented.
- Any damage to the equipment is the responsibility of the renting party.
- Any charges for the repair and/or replacement of the equipment shall be charged back to the renting party.
- The HOC is not responsible for setup and takedown and will not be onsite during the scheduled meet/event.

- The HOC is not responsible for any facility bookings (RLTFC or other).
- Please schedule a pickup and return time the day of the event and a point of contact with cell number provided.
- The renting party is responsible for the proper assembly and use of the equipment and is liable for any damages or injury caused by the improper assembly and use of the equipment to the athletes, officials, volunteers or spectators.
- Renters Must Carry Liability Insurance.

Acceptance of Risk and Waiver of Liability

- The Renter acknowledges that the use of the equipment involves certain risks.
- Risks may include, but are not limited to, physical injury, damage to property, and potential death.
- The Renter voluntarily assumes all related risks.
- The Renter agrees to release, indemnify, and hold harmless HAMILTON OLYMPIC CLUB and its employees, agents, and affiliates from any and all claims of negligence, loss, damage, injury, or death resulting from the use of the equipment.
- This waiver and release are binding on the Renter's heirs, executors, administrators and assignees
- Renter agrees to use the equipment in a safe and appropriate manner and shall comply with all applicable laws, rules, and regulations for its use.
- The Renter shall not sublease or assign the equipment to any third party without the written consent of HAMILTON OLYMPIC CLUB.
- It is the responsibility of the party or parties hiring this "Equipment" for rental to ensure that all possible precautions are taken to prevent any risk of personal injury, and to prevent any risk of damage to the equipment itself.
- The Equipment has been received by the Renter in good condition. It will be returned in comparable condition.
- The Renter assumes all responsibility for any damage to the Equipment, or for any injury to persons as a result of using the Equipment, during the rental period.
- The Renter agrees to release and hold HAMILTON OLYMPIC CLUB harmless from any and all claims, of any nature, arising from the Renter's use of the equipment during the rental period. In the event that this directive to release and hold harmless proves itself legally unenforceable, the Renter hereby agrees to limit any damages claimed by the Renter.
- The Renter hereby agrees to pay any replacement or repair costs, including labor, incurred through damages to the Equipment during the rental period
